#### RESEARCH AWARD 2024 -"Bold Ideas for Science"-

The University Executive Board grants a research award to scientists with the aim of promoting and supporting extraordinary, non-mainstream research projects. The aspect of interdisciplinarity is given special consideration.

#### SCOPE OF AWARD AND FUNDING:

- WHAT: Support and promotion of extraordinary, non-mainstream research projects with visionary ideas, bold hypotheses, creative and unconventional technologies or innovative and courageous methods
- **WHO:** Scholars/scientists or project teams who are qualified for independent research (postdoc level and higher, active integration into Paderborn University is required)
- **HOW MUCH:** 150,000 EUR is provided for a period of 1.5 years
- **WHAT FOR:** Flexible use of the funds (general expenses, material costs, travel expenses, personnel costs however not to finance the applicant's own position)
- WHEN: Annual call for applications, deadline: 22-05-2024

The Committee for Research and Junior Academics conducts the academic review and evaluation on the basis of the submitted documents. This year's **presentation date** as part of the selection process is **16 July 2024**, so please make a note of this date now.

After the end of funding, your project must be presented a. o. to the Research Committee and the University Executive Board in the form of a presentation (30 minutes) at the 'Research Day 2026'.

#### Guideline Paderborn University Research Award - "Bold Ideas for Science" -

#### 1. The Concept

Extraordinary research projects (with an interdisciplinary approach) that feature visionary ideas, bold hypotheses, creative and unconventional technologies or innovative and courageous methods outside the mainstream should be given the opportunity to be realised. In the process, the most innovative approaches, ways of thinking, mindsets and methods from various disciplines should be taken into account. We are looking for projects that are completely new and unusual and might challenge currently accepted knowledge and expertise. Funding is provided for an initial project phase with the aim of examining and testing out this idea more closely. If the project fails or is not feasible, an explanation of the obstacles that hindered it is the desired result.

It is only the innovative and bold research idea that counts.

#### 2. Applicants / Project Team

The following formal requirements must be met and apply to co-applicants as well.

- Completed doctoral degree or higher academic qualification (you must be qualified for independent research)
- You must have a verifiable employment contract with UPB
- Active involvement in research and teaching is required

#### 3. Funding

- The amount of the funding is 150,000 EUR
- The duration of the funding period is max. 18 months.
- One project will be supported each year.
- The funds can be used flexibly for all material and personnel costs incurred, but the funds must explicitly and demonstrably serve the purpose of achieving the research objective, e.g.:
  - Involvement of cooperation partners from the academic/scientific community (in Germany and other countries)
  - Research stays at other institutions
  - Invitations to visiting scholars/researchers
  - Workshops or project meetings

The funding cannot be used to finance the applicant's own position.

- Only one idea/project outline per person/project team can be submitted during each application period.
- Ideas that have already been rejected cannot be presented again, generally not in a modified or revised form either.

#### 4. Formatting Specifications

The application documents should be submitted as follows: Page format A4, font Arial, font size 11 point, line spacing no less than 1.2, page margin "normal"



#### 5. Application Documents

The following documents must be submitted:

- a) Completed application form (<u>https://www.uni-paderborn.de/en/zv/formulare</u>)
- b) Introductory profiles of the researchers involved and their research focus areas
- c) Short CV (max. 2 pages), including information about your position at the institute and listing up to ten selected publications (if applicable, short CVs of co-applicants)
- d) Doctoral degree certificate of Young Scientists
- e) Project outline (max. 76 lines)
- f) Cost plan / information on the planned use of funds (see information in Section 3; max. 1 page)
- g) Declaration of consent to data processing (originally signed by applicants and co-applicants)

The application must be submitted to the Committees Head Office, Department 2.2, in electronic form (1 PDF file).

#### Project outline (max. 76 lines)

Use the following structure for your outline:

- 1. Idea: Describe your research idea, highlighting the unique, bold aspects and unusual methods (max. 20 lines)
- 2. Objective: Describe the specific desired objective (max. 3 lines)
- 3. Methods: Outline the methods you indicated that should lead to the success of the concept (max. 20 lines)
- 4. Prospects of success: Describe the expected gain in knowledge and insights weighed against the possible risks (max. 10 lines)
- 5. Relevance to the research award: Why should Paderborn University consider your research idea? In particular, also describe why your project has an interdisciplinary nature. Explain the value and importance of your research project for the academic/scientific community (20 lines)
- 6. Summary: What makes your project special, and a more bold one, in comparison to others, and why will the findings enrich academia/science if it is successful (max. 3 lines)?

#### 6. Application Dates and Deadlines

The current application dates and deadlines are announced on the website of the Committee for Research and Junior Academics (FK) and can also be found in the current call for applications. The plan is to award the prize on an annual basis.

#### 7. Selection and Evaluation Process

The selection takes place in two consecutive FK meetings (1<sup>st</sup> session: preliminary selection based on the application documents; 2<sup>nd</sup> session: invitation of up to 3 candidates to present the research project). All programme requirements as well as the merit and coherence of the idea/project outline are considered in the preliminary selection.



#### 8. Award Ceremony and Presentation

A quick project start is essential. The award itself is presented during Paderborn University's New Year's reception. About two years after being granted the award, the award winners will be invited to a presentation, at the University's Research Day, where they will present their results in the form of a presentation (30 minutes), regardless of whether the project is successful, fails or is not feasible. The aim is to further develop the "Paderborn University Research Award" funding initiative based on the experiences of the funded project participants. The winners will be notified of the date of the presentation 4 months in advance.

The legal basis here is Article 6, Para. 1 (1) e), Para. 3 (1) b) of the GDPR in conjunction with § 3, Para. 1 of the North Rhine-Westphalia Data Protection Act (DSG NRW) in conjunction with § 3, Para. 1 of the North Rhine-Westphalia Higher Education Act (HG NRW) in conjunction with the current valid version of Paderborn University's guidelines on the award of research prizes; where applicable, Article 9, Para. 2 a) of the GDPR, where sensitive data is (has) to be taken into account in accordance with Article 9, Para. 1 of the GDPR for the award of the research prize.

#### 3. Transfer of your personal data

Your personal data, which will be processed by Paderborn University within the scope of the award of a research prize, will in principle not be transferred to any third parties without your consent and subject to the transmission of data described below. In individual cases, data may also be transferred in compliance with a legal requirement. Where (technical) service providers have access to personal data, this access will be regulated on the basis of an arrangement pursuant to Article 28 of the GDPR. For data that is processed jointly with other data controllers, this joint processing will, where required, be regulated on the basis of an arrangement pursuant to Article 26 of the GDPR.

In principle, no personal data will be transferred to countries outside the European Economic Area (EEA) and associated countries (no "third country transfer").

#### Important note if your personal data is made available online:

Where appropriate, documents will be transferred to the University Archives and generally stored there indefinitely. All other data of research prize winners whose application is approved will be erased/destroyed one year after the funding period has ended.

The names of the research prize winners, details about their research project and a laudation of the awarded project will be published on Paderborn University's website permanently or until such consent is revoked.

#### 5. Your rights as a data subject

As a data subject, you may assert the rights granted to you by the GDPR at any time; these are:

- The right to know if and what personal data concerning you is being processed, in accordance with Article 15 of the GDPR, § 12 of the DSG NRW
- The right to have any inaccurate personal data concerning you rectified or incomplete personal data completed, in accordance with Article 16 of the GDPR
- The right to have your personal data erased, in accordance with Article 17 of the GDPR, § 10 of the DSG NRW
- The right to restrict the processing of your data, in accordance with Article 18 of the GDPR
- The right to receive the personal data concerning you, in accordance with Article 20 of the GDPR

#### 6. Right to withdraw your consent and to object to the processing of your personal data

Any consent that may have been granted can be revoked (withdrawn) in whole or in part at any time without providing a reason. The withdrawal of consent shall not affect the lawfulness of processing based on the consent before its withdrawal (Article 7, Para. 3 of the GDPR). Consequently, Paderborn University will no longer be



permitted to process your data on the basis of this consent in the future and must erase your personal data, unless there is another legal basis for processing (Article 17, Para. 1 b) of the GDPR). In the event that you withdraw your consent to the processing of your personal data during the research prize application process, it will no longer be possible to consider you in the award process. In the event of a revocation of your declaration of consent for recordings and/or publications (of data on) your person, active participation in the award ceremony (as an award winner) is not possible in the case of an award.

In accordance with Article 21 of the GDPR, you have the right to object, on grounds relating to your particular situation, at any time to the processing of personal data concerning you which is collected on the basis of Article 6, Para. 1 (1) (e) of the GDPR. The right to object pursuant to Article 21 of the GDPR vis-à-vis a public-sector body does not apply where there is a compelling public interest for processing that overrides the interests of the data subject concerned or if a legal provision requires processing (§ 14 of the DSG NRW).
