## **INFORMATION ON THE PROCESSING OF YOUR PERSONAL DATA WITHIN THE SCOPE OF THE AWARD OF PRIZES FOR OUTSTANDING DISSERTATIONS PURSUANT TO ARTICLE 13 OF THE GENERAL DATA PROTECTION REGULATION (GDPR)**

This data protection notice describes how your personal data is processed within the scope of the award of prizes for outstanding dissertations (“dissertation prizes”) at Paderborn University. By issuing this data protection notice, Paderborn University is complying with its duty to provide information pursuant to Article 13 of the EU General Data Protection Regulation (GDPR). With regard to the terms used in the following, e.g. “personal data”, “processing”, “Controller” etc., please refer to the definitions in Article 4 of the GDPR.

### **1. Names and contact details**

The purpose of processing your personal data is to conduct the dissertation prize selection process and, where applicable, to award you a dissertation prize (including administration) in recognition of your outstanding dissertation.

The legal basis for the processing of your personal data within the scope of the application process, the provision of advice and any transfer of personal data on you and that names you to the funding provider, as well as in the event of the publication of your personal data (name and/or image etc.) is your consent pursuant to Article 6, Para. 1 (1) a) of the GDPR; where applicable, Article 9, Para. 2 a) of the GDPR, where sensitive data pursuant to Article 9, Para. 1 of the GDPR is the subject of the above-mentioned data processing (e.g. health-related data in your curriculum vitae).

The processing of your personal data within the scope of prize award administration and for statistical analyses, for example, is necessary for the performance of tasks by Paderborn University in the public interest. The legal basis here is Article 6, Para. 1 (1) e), Para. 3 (1) b) of the GDPR in conjunction with § 3, Para. 1 of the North Rhine-Westphalia Data Protection Act (DSG NRW) in conjunction with § 3, Para. 1 of the North Rhine-Westphalia Higher Education Act (HG NRW) in conjunction with the current valid version of Paderborn University's guidelines in the call for applications for the award of dissertation prizes; Article 6, Para. 1 (1) e), Para. 3 (1) b) of the GDPR in conjunction with § 17, Para. 1 of the DSG NRW and, where applicable, Article 9, Para. 2 a) of the GDPR, where sensitive data pursuant to Article 9, Para. 1 of the GDPR has to be taken into account for the award of dissertation prizes.

With regard to payments made in connection with the dissertation prize, Paderborn University is legally obliged to transmit personal data on you (payment notices) to the competent tax authority as part of a tax disclosure report, in accordance with the relevant requirements. The legal basis here is Article 6, Para. 1 (1) c), Para. 3 (1) b) of the GDPR in conjunction with § 2, Para. 1 of the German Transaction Reporting Regulations (MV).

Paderborn University is responsible for the deduction of income tax and social security contributions from the remuneration component of the prize money and, where necessary, will arrange for the prize money to be paid out via the North Rhine-Westphalia State Office for Salaries and Benefits (LBV NRW). The legal basis for the transmission of payment information on prize money to the LBV arises from Article 6, Para. 1 (1) c) of the GDPR in conjunction with the requirements of the German Income Tax Act (EStG).

## 2. Transfer of your personal data

Your personal data, which will be processed by Paderborn University within the scope of the award of dissertation prizes, will in principle not be transferred to any third parties without your consent and subject to the transmission of data described below. In addition to the transmission of tax disclosure reports on prize money payments to the competent tax authority and any transmission of payment information to the LBV, as described under Section 2, in individual cases, data may be transferred exclusively in compliance with a legal requirement. Where (technical) service providers have access to personal data, this access will, where required, be regulated on the basis of an arrangement pursuant to Article 28 of the GDPR. For data that is processed jointly with other data controllers, this joint processing will, where required, be regulated on the basis of an arrangement pursuant to Article 26 of the GDPR.

In principle, no personal data will be transferred to countries outside the European Economic Area (EEA) and associated countries (no “third country transfer”).

Please be aware that if your personal data is published online, it will be possible for any person worldwide to access this personal data – for example with the help of search engines (e.g. Google). ## 3. Duration of storage of your personal data

If and to the extent that the processing of your personal data is based on your consent, your data will be stored only until you withdraw your declaration of consent, unless there is another legal basis for processing (Article 17, Para. 1 b) of the GDPR).

The personal data of applicants for a dissertation prize whose application is not approved will be erased/destroyed in accordance with data protection regulations at the latest six months after the application process has been completed.

Basic data concerning the dissertation prize applicants, dissertation prize winners, project team, faculty, dissertation details and details on the selection decision will be stored in the selection committee’s records for ten years and then erased. Where appropriate, documents will be transferred to the University Archives and generally stored there indefinitely. All other data on prize winners whose application is approved will be erased/destroyed one year after the funding period has ended.

Data on participants pertaining to the payment of prize money will be erased/destroyed 10 years after the end of the funding period.

## 4. Your rights as a data subject

As a data subject, you may assert the rights granted to you by the GDPR at any time; these are:

- The right to know if and what personal data concerning you is being processed, in accordance with Article 15 of the GDPR in conjunction with § 12 of the DSG NRW
- The right to have any inaccurate personal data concerning you rectified or incomplete personal data completed, in accordance with Article 16 of the GDPR



- The right to have your personal data erased, in accordance with Article 17 of the GDPR in conjunction with § 10 of the DSG NRW
- The right to restrict the processing of your data, in accordance with Article 18 of the GDPR
- The right to receive the personal data concerning you, in accordance with Article 20 of the GDPR

## **5. Right to withdraw your declaration of consent and to object to the processing of your personal data**

You have the right to withdraw your consent, in whole or in part, at any time, without giving a reason. The withdrawal of consent shall not affect the lawfulness of processing based on the consent before its withdrawal (Article 7, Para. 3 of the GDPR). Consequently, Paderborn University will no longer be permitted to process your data on the basis of this consent in the future and must erase your personal data, unless there is another legal basis for processing (Article 17, Para. 1 b) of the GDPR). In the event that you withdraw your declaration of consent to photographs/recordings of you and/or the publication of data about you, you will not be able to actively participate in the dissertation prize award ceremony (as a prize winner) if you are awarded a prize.

In accordance with Article 21 of the GDPR, you have the right to object, on grounds relating to your particular situation, at any time to the processing of personal data concerning you which is based on Article 6, Para. 1 (1) e) of the GDPR. The right to object in accordance with Article 21 of the GDPR vis-à-vis a public body does not apply where there is a compelling public interest for the processing that overrides the interests of the data subject or where a legal provision requires the processing (§ 14 of the DSG NRW). In the event that you object to the processing of your personal data within the scope of prize award administration, you may no longer be awarded a prize.

## **6. Right to lodge a complaint**
